# HEVC Advance Patent Pool: Brief Introduction to New Platform License

# New Platform License Overview

## Existing HEVC Advance Patent Portfolio License (“PPL”) simplified to create new HEVC Advance Platform PPL

- Expands License to cover all current HEVC versions (i.e., thru Version 7) and Optional Features currently covered by Amendment
- Consolidates existing separate royalties for all Advanced Profiles and separate royalties for Optional Features into the existing Main/Main 10 royalty rates
- Caps remain the same as existing license but separate caps for Optional Features Patents have been eliminated
- Initial Term through 12/31/2025 with automatic extension thru 12/31/2030

# New Platform License Overview

## Choices for HEVC Patent Implementers and Existing HEVC Advance Licensees

- Existing Licensees can keep their existing HEVC Advance PPL or replace their existing PPL with the new HEVC Advance Platform PPL described herein.
- New Licensees would execute the new HEVC Advance Platform PPL.

## Why Existing Licensees Should Sign the New HEVC Advance Platform PPL

- Until the new HEVC Advance Platform PPL is signed, Licensees owe royalties in addition to the Main/Main 10 royalties for any sales of devices with Version 2 Advanced Profiles and/or Optional Features.
- If an audit shows any unreported sales of devices with Version 2 Advanced Profiles and/or Optional Features, royalties *will be due* for these additional sales.
- Executing the new HEVC Advance Platform PPL is a requirement to take advantage of the HEVC + VVC Multi-Codec Bridging Agreement.

# HEVC Advance Program – General Pool Terms

## TOPIC: What Versions of the HEVC Standard are Included?

- Our new Platform HEVC Program includes a license to all versions through Version 7 of ISO/IEC 23008-2 MPEG-H Part 2 and ITU-T Recommendation H.265<sup>(1)</sup>, including Optional Features<sup>(2)</sup> (“HEVC Standard”)
- Other profiles, extensions, and versions thereof, and new standards separated therefrom (e.g., SEI messaging), as are adopted by the applicable standards setting organizations, may be added in the future upon written notice of Access Advance

(1) For certain Licensors, the license grant is limited through Version 2 only. See the HEVC Advance Patent List.

(2) Access Advance licenses “Essential Patents on Optional Features.” which means any patent claim covering a feature described in the HEVC Standard that is not required to be implemented in an HEVC Product, but which, if the feature is implemented, must be implemented within the scope of the HEVC Standard and which implementation would necessarily or unavoidably infringe such patent claim.

# HEVC Advance Program – General Pool Terms

## TOPIC: What Do We License – Devices and Software

We license HEVC Decoders and Encoders (i) in Consumer HEVC Products or (ii) made available for use through Cloud Based Services:

- Royalty rates based on three device categories:
  - Mobile Devices (e.g., Mobile Phone, Tablet, Laptop PC)
  - Connected Home and Other Devices (e.g., Set-Top Box, Game Console, Blu-ray Player, Desktop PC, non-4K UHD+ TV, Software, Surveillance Cameras, Conferencing Products, Medical Imaging, Digital Signage)
  - 4K UHD+ Television/Display (e.g., UHD-capable televisions, projectors, VR/AR headsets)

# HEVC Advance Program – General Pool Terms

TOPIC: What Do We License – Devices and Software, continued

- Primary model is licensing HEVC decoders/encoders installed on devices at date of First Sale
- Intent is to be paid one royalty per device on First Sale. Multiple HEVC encoders and/or decoders installed in a device prior to the device's First Sale incur ONLY a single royalty fee at the highest applicable rate upon the device's First Sale, with limited exceptions
- Royalty due for HEVC Software Sold separately from a device and for preloaded HEVC pay-to-use software for which a separate payment is due
- Royalty due for HEVC decoders and encoders used to provide or made available for use through a Cloud-Based Service



# HEVC Advance Program – General Pool Terms

## TOPIC: What Do We License – Commercial Content Distribution on Physical Digital Media

- We license Commercial HEVC Content stored on Physical Digital Media:
  - HEVC Content on Physical Digital Media Storage (e.g., Blu-ray discs, external hard drives, etc.)
  - Box sets and bundled HEVC Content owe a separate royalty for each optical disc. For other digital media (e.g., video pack) that contains multiple Titles, a royalty is due for each Title

# HEVC Advance Program – General Pool Terms

## TOPIC: What Do We NOT License?

- We do not license:
  - “Commercial Products” primarily intended or marketed to encode or transmit Commercial HEVC Content or provide a Cloud Based Service
  - Non-physical HEVC Content distribution (e.g., internet streaming, cable, over-the-air broadcast, and satellite)

# HEVC Advance Program – General Pool Terms

## TOPIC: How Are Patents Evaluated?

- Access Advance has retained the law firms of Mintz, Levin, Cohn, Ferris, Glovsky and Popeo, P.C. and Wolf, Greenfield and Sacks, P.C. as independent Patent Evaluators to provide global patent essentiality determinations.
- These independent Patent Evaluators have engaged multiple patent law firms around the world to draw upon their country-specific expertise as needed.

# HEVC Advance Program – General Pool Terms

## TOPIC: What Patent Rights Are Licensed?

- Our License covers all of our Licensors' HEVC Standard essential patent claims that they have the right to license<sup>(3)</sup>
- Our Patent List identifies Licensor patents that include one or more claims found to be essential to the HEVC Standard by our Independent Patent Evaluators
- Our Patent List identifies the significant portion(s) of the HEVC Standard to which the essential patent claims map
- All essential claims are included – even those essential claims in Licensor patents that have not yet been evaluated by our independent Patent Evaluators

(3) Except as noted on the HEVC Advance Patent List.

# HEVC Advance Program – General Pool Terms

## TOPIC: Whom Do We License?

- Parties that sell Consumer HEVC Products:
  - Parties that Sell substantially completed devices or software (i.e., ready for sale to an End User) that incorporate one or more HEVC decoders and/or encoders<sup>(4)</sup>
  - Parties that (a) provide End Users with access to HEVC encoders and/or decoders through the internet or another public or private network or (b) process content at the End User's request using HEVC encoders and/or decoders where the output is returned to the End User
  - Parties that sell HEVC Content on Digital Media Storage:
  - Parties that Sell (e.g., commercially distribute) HEVC Content on Physical Digital Media Storage (Blu-ray discs, external hard drives, etc.) to End Users<sup>(4)</sup>

(4) Access Advance reserves the right to seek licenses from any party infringing HEVC Standard essential patents of our Licensors for all their infringing products. Our primary focus, however, is to (1) license parties selling Branded products to End Users directly or through a Chain of Distribution, and (2) OEM's and other parties that customarily handle licensing obligations in certain market segments.

# HEVC Advance Program – General Pool Terms

## TOPIC: Where and When is a Royalty Due?

- A royalty is due upon the Sale of a Consumer HEVC Product or HEVC Content on Digital Media Storage for which an HEVC Standard Essential Patent (listed on the HEVC Advance patent list) is in force in either the country/territory of manufacture or the country/territory of Sale.
- If there are no patents in both the country/territory of manufacture and the country/territory of Sale, then no royalties are due for Consumer HEVC Products or HEVC Content on Digital Media Storage Sold in that country/territory.

# HEVC Advance Program – General Pool Terms

## TOPIC: Royalty Rate Structure

- Geographic Rate Differentials: Stated rates apply to the country/territory in which the Consumer HEVC Product and HEVC Content on Digital Media Storage is first Sold.
- Royalty reduction (50% discount) if the First Sale is in a country/territory in Region 2 (an emerging market), except for Connected Home and Other Devices Sold at or below \$80.
- Region Definitions:
  - Region 1 = U.S., EU, UK, Japan, S. Korea, Australia, New Zealand, etc. See a complete list of countries/territories on the Advance website.
  - Region 2 = All countries/territories outside of Region 1.

# HEVC Advance Program – General Pool Terms

## TOPIC: Royalty Rate Structure

- Royalty rates shown include separate and non-additive discounts for being In-Compliance and for using the HEVC Advance Trademark Logo
- Standard Rates (i.e., non-discounted rates) apply if Licensee is not In-Compliance
- Main, Main Still and Main 10 profiles + Advanced Profiles (Rext, MV-HEVC, and SHVC) + Versions 3-7 + Optional Features (e.g., SEI messages) are included in a single Per-Device Royalty (see Royalty Rates and Structure, beginning on page 34 )
- Royalty Rate Term Increase Cap: Royalty rates and caps will not increase more than 20% for any Renewal Term



# HEVC Advance Program – General Pool Terms

## TOPIC: Annual In-Compliance Royalty Caps

- Multiple Cap Categories (i.e., Mobile Devices, Connected Home and Other Devices, 4K UHD+ Television/Display, and HEVC Content on Digital Media Storage), generally excluding HEVC Software.
- Single Enterprise Cap for aggregate of all Categories, generally excluding HEVC Software.
- Affiliates included under a Licensee's PPL receive the benefits of the caps.
- Caps apply only during those quarterly reporting and payment periods in which a Licensee and its Affiliates are In-Compliance.
- All caps reset annually on January 1 of each year.
- Standard Rates are not capped (i.e., royalties owed at Standard Rates do not accrue against any caps).

# HEVC Advance Program – General Pool Terms

## TOPIC: Annual Enterprise Credit

- Annual Enterprise Credit of \$25,000 applies to all Enterprises that owe royalties and are In-Compliance.
- The credit is provided in four equal quarterly installments of \$6,250 each.
- Unused credit amounts do not carry over to future quarters.

# HEVC Advance Program – General Pool Terms

## TOPIC: Term of License

- Licenses are offered in five (5) year non-terminable increments ending December 31, 2025, and every 5 years thereafter until all Licensors' essential patents have expired.
- For each license, the initial 5-year non-terminable term is automatically renewed for an additional non-terminable 5-year term, unless terminated by Licensee in the event there is a change to the license which has a material adverse impact on Licensee (other than a permitted rate increase).
- For example, Licensees that executed the license after Dec. 31, 2020 would be automatically renewed on Dec. 31, 2025 through Dec. 31, 2030, unless terminated as noted above.

# HEVC Advance Program – General Pool Terms

## TOPIC: Patent Marking

- Patent marking is required for Consumer HEVC Products and HEVC Content on Digital Media Storage. A reference to the public patent list published on the Advance website is allowed (in accordance with applicable legal requirements).

# HEVC Advance Program – General Pool Terms

## TOPIC: HEVC Advance Logo

- Option available to include the HEVC Advance Logo on all Licensed Products or their physical device packaging in return for a 10% discount that is included in the published device royalty rates for “In-Compliance with Trademark”. Logo usage guidelines can be found on Advance’s website.
